This **STALLION BREEDING CONTRACT FOR SHIPPED, COOLED SEMEN** for the breeding season of 20____, made and entered into on this _____ day, of _____, is by and between Barger Quarter Horses, hereinafter designated Breeder, and _____, hereinafter designated Mare Owner.

Mare Owner agrees to breed the mare _____, Reg. No. _____, (please include a copy of mares registration papers), to the stallion, **ZIPPO HOT PINE #3525013** for the fee \$ _____ for a live foal.

Stud fee subject to the following conditions:

1. The stallion fee includes a non-refundable booking fee of \$ _____, payable with this contract, the balance of which must be paid before semen is shipped.
2. Breeder agrees to ship semen as described in the attached **STALLION SERVICE SHIPPING AGREEMENT** provided by Buddy Talbert Quarter Horses, Blountville, TN. Please be advised that semen will not be shipped unless payment has been arranged in advance.
3. This Contract contains a "Live Foal Guarantee." A live foal is described as a newborn foal, which stands and nurses. If foal is born dead, there are return privileges, as outlined in the attached **STALLION SERVICE SHIPPING AGREEMENT**.
4. A "Breeder's Certificate" will be issued for the foal, conceived by this mating, when ALL stallion fees and all other expenses have been paid in full; and, when mare has produced a live foal by this mating. It is the mare owners responsibility to contact the breeder to request a breeders certificate.
5. It is further agreed that should the stallion die, be sold by the owner, or become unfit for service prior to settling the mare, that 80% of the breeding fee (less expenses owed) will be refunded, if it has been paid in full, thereby canceling this entire contract; or, if mare dies or becomes unfit to breed before being pronounced safe in foal, the Breeder has the option to accept another mare as a replacement, or a return for the following season only.
6. This contract is non-assignable and non-transferable.
7. This contract is entered into the State of Virginia, and will be interpreted and enforced under the laws of that state. If any clause in the Contract is against State Law, then that clause becomes null and void.
8. The following rider is attached hereto and made a part hereof: **STALLION SERVICE SHIPPING AGREEMENT**.
9. This Contract represents the entire agreement between the parties. No other agreements, promises, verbal or implied, are included unless specifically stated in this written Contract. Original contract will be kept on file at Barger Quarter Horses and a copy provided for mare owner.

When Mare Owner and Breeder have signed this Contract, it will be binding on both parties, subject to the above terms and conditions.
